# The American College of Employee Benefits Counsel

Washington D.C. – The American College of Employee Benefits Counsel (ACEBC®) has named Ms. Emily Bingham, a third-year law student at the University of Minnesota Law School, and Ms. Nell Cormack, a 2025 Juris Doctorate recipient from Drexel University Thomas R. Kline School of Law, as the winners of the College's 2025 Student Writing Competition Awards.

Ms. Bingham won the **2025 Sidney M. Perlstadt Memorial Award** for her paper entitled ***States Shouldn't Bank on the Savings Clause: An Analysis of the Department of Labor's Savings and Deemer Clause Arguments in PCMA v. Mulready.***

Ms. Cormack's winning entry entitled ***The 10% Additional Tax on Early Distributions for Retirement Plans: Sound Policy or a Penalty for Being Poor?*** won the **2025 Brian J. Dougherty Memorial Award**.

Professor Norman Stein and Frances King Quick, Co-Chairs of the Student Writing Competition Committee, presented the awards at the College's 2025 Induction Ceremony held on Saturday, November 8, 2025, in Charleston, South Carolina at the Francis Marion Hotel.

Ms. Melissa Welch, a third-year law student at Georgetown University Law Center, received Honorable Mention for her paper entitled ***Do Employee Wellness Programs Need a Check-Up?***
